Sub: Extension of the tenure of the Managing Committees/Ad-hoc Committees/Administrators of Recognised Non-Govt. Secondary Schools (aided and unaided).

Pursuant to the commencement of academic session from 1st February for the academic year 1st February, 2011, to 31st December, 2011, Circular No. S/70 dated 24-01-2011 was issued by the Board to start the election process for constitution/reconstitution of the Managing Committees after 15th April, 2011, and extension of the term of the Managing Committees/Ad-hoc Committees/Administrators was allowed on certain conditions upto 31-07-2011 or till constitution/reconstitution of the Managing Committee whichever is earlier.

But in view of enforcement of the model code of conduct for the General Election to the West Bengal Legislative Assembly, 2011, the election process for constitution/reconstitution of the Managing Committees could not be started upto the date of declaration of the result of the said General Election to the West Bengal Legislative Assembly, 2011, and thereafter the Schools remained closed for summer vacation.

Under the circumstances, the President, West Bengal Board of Secondary Education, in exercise of the power conferred by the sub Section 2 of Section 28 of the West Bengal Board of Secondary Education Act, 1963, as amended, read with Rule 8(2) & 12 of the Rules for Management of Recognised Non-Govt. Institutions (aided and unaided), 1969, as amended, has been pleased to grant extension of the tenure of the Managing Committees/Ad-hoc Committees/Administrators of the Recognised Non-Govt. Secondary schools (Aided & Unaided) upto 31-10-2011 or till reconstitution of the Managing Committees whichever is earlier, to avoid administrative vacuum in the schools.

Conditions stipulated in the said earlier Circular No. S/70 dtd. 24.01.2011 remain unchanged.


