## ORDER

An order was placed on M/s. Mrinal Dutta to lifting of residual quantity of Old Answer Scripts pertaining to Kolkata Region vide memo no. N/S/330 dt.18/02/2015, according to the Terms & Conditions of the relevant tender.

Whereas, the Party had lifted the entire residual quantity of old answer scripts. The Party was required to deposit the sale proceed immediately on handing over the material as per agreed term & condition. But inspite of repeated follow-up the Party had not turned up to make the necessary payment which had forced the Board to adjust the said sale proceeds with the security deposit kept with the Board. This had resulted with some financial loss due to short recovery because of inadequacy of the Security Deposit.

In consideration of this willful default on the part of the Party, the reliability of the party has come into serious question and hence M/s.Mrinal Dutta is hereby debarred from participating in any future tender to be issued by the Board for a period of 3 years.

## ORDER

M/s.Arun Trading Co. was awarded a contract for sale of old Answer Scripts on the basis of highest offer vide order no. N/S/301 dt. 18/12/2014.

Whereas during execution of the work the Party failed to complete the lifting of material within stipulated time viz. 15/01/2015 inspite repeated follow up by the Board's representative. Because of this default on the part of the concerned party the Board had to experience tremendous worries as regards completion of the job which was strictly time bound in view of facilitating the process for conducting Madhyamik 2015 as per time schedule.

Whereas on continuous insistence from the Board's representative, the party had lifted partial quantity of answer scripts pertaining to Kolkata and Medinipur Region and as regards Burdwan and North Bengal Region it had not lifted any material despite continuous follow-up. Regarding the materials lifted from Kolkata & Medinipur as aforesaid the party had issued 2 nos. cheques bearing No. 165031 dt.16/12/15 for Rs.2,68,546/- and 000011 dt.09/02/15 for Rs.1,83,910/- towards part payment of the value of materials lifted against which the party had subsequently issued "STOP PAYMENT" instruction to drawee banker and the cheques were dishonoured. This particular amounts are yet to be received from the party.

In consideration of the aforesaid malicious intention and act on the part of the party for which the Board has incurred substantial financial loss as well as suffered great amount of inconvenience in carrying out the work as per time schedule. M/s. Arun Trading Co. is hereby debarred from participating in any future tender to be issued by the Board for a period of 3 years.
