Sub :(i) Postponement of Election for Constitution/ Reconstitution of the Managing Committee of the Recognised Secondary Schools in view of the revised programme of Panchayet Election, 2013.

(ii) Extension of the tenure of the Managing Committees/Ad-hoc Committees/ Organising Committees/Administrators upto 31.10.2013

Ref: Board's Circular No.87/Admin/13 dt. 31.05.2013.

Referring to the Circular No. 87/Admin/13 dated 31.05.2013 issued earlier by the Board on the above noted subject, I, in exercise of the powers conferred upon the Administrator by Sub-Section 2 of Section 28 read with Sub-Section 1(b) of Section 50 of the W.B.B.S.E. Act, 1963, as amended, am pleased to notify further that in view of the declaration of revised programme of Panchayet Election to be held on 11.07.2013, 15.07.2013, 19.07.2013, 22.07.2013 & 25.07.2013 in the State of West Bengal through Notification on 3.07.2013, the entire process of Constitution/Reconstitution of the Managing Committee shall remain suspended upto 29.07.2013 or the date of declaration of the result of Panchayet Election by the enforcement of the Model Code of Conduct on and from 3.07.2013.

In paragraphs 1, 2, 3 & 4 of the earlier Circular under reference, only the dates mentioned therein as 27.05.2013 & 13.07.2013 are hereby revised and they shall please be read as 3.07.2013 and 29.07.2013 or till the declaration of the result of Panchayet election, in place of 27.05.2013 and 13.07.2013 respectively, keeping the remaining part of the Circular unchanged.
