<u>Sub</u>: (i) Postponement of Election for Constitution/Reconstitution of the Managing Committee of the Recognised Secondary Schools in view of the ensuing Panchayat General Election 2008:

(ii) Extension of the tenures of the Managing Committee/ AdhocCommittee/ Organising Committee / Administrators upto 31.10.2008.

In cancellation of the Board's previous Notification No S/91 dated 11.4.08, the undersigned is directed to issue a revised Notification S/91Aon the above noted subject for information of all concerned.

In exercise of the powers conferred by Sub Section 2 of Section28 of the W.B.B.S.E. Act, 1963(W.B.Act of 1963), the President is pleased to notify that in view of the declaration of Panchayet General Election to be held on 11.5.08, 14.5.08 & 18.5.08 in this State of West Bengal through notification and enforcement of the Model Code of Conduct from 9.4.08, the entire processes of Constitution/Reconstitution of the Managing Comittees shall remain suspended upto the date of declaration of result of Panchayet Election i.e. upto 30.5.08.

1. In cases of schools where the processes of election for the different categories have already been started but not completed till 9.4.08,the

remaining part shall be started after 15.7.08 adopting fresh programmes as per normal rules and procedure.

- 2. In cases of schools where elections of different categories other than Office Bearers have already been completed prior to the declaration of dates for ensuing Panchayet Election i.e. 9.4.08, the election of Office Bearers shall stand deferred upto 31.5.08 and shall be completed within 31.10.08 as per provisions of Management Rules.
- 3. Schools whose election is due but have not yet adopted any programme for election to Constitute/ Reconstitute the Managing Committee will take steps for Constitution/Reconstitution of the Managing Committee as per Management Rules after 15.7.08.
- 4. Schools which have completed the processes of election in between 9.4.08 and 15.4.08 shall report to the Board for consideration and decision.
- 5. The tenure of the Managing Committee / Adhoc Committee / Organising Committee/ Administrator of the Secondary Schools that will come under the category 1, 2& 3 above is extended upto 31.10.2008 or till completion of Constitution/reconstitution of the Managing Committee, whichever is earlier.
- 6. The Board, however reserves the right to appoint Administrator/ Ad-hoc Committee where the same would be necessary for administrative reasons.
- 7. The above notification is not applicable to schools where any contrary order from the Hon'ble Court prevails.
