Sub: Postponement of election for Constitution/ Reconstitution of the Managing Committee of Recognised Secondary Schools (Aided & Unaided) in view of the declaration of Bye-election in Parliamentary Constituency in two districts i.e. Kolkata and South 24 Parganas in West Bengal.

In exercise of the powers conferred by Sub-Section (2) of Section 28 of the West Bengal Board of Secondary Education Act, 1963(W.B. Act of 1963), the President is pleased to notify for general information that in view of the Bye-election in Parliamentary Constituency, i.e. 'Dakshin Kolkata' in two districts mentioned above declared by the competent authority through notification and enforcement of the Model Code of conduct with effect from 5/11/2011 to the date of declaration of result of Bye-election, the process of Constitution / Reconstitution of the Managing Committee in recognised Secondary schools shall remain suspended from the date of notification of the Model Code of Conduct to the date of declaration of result of Bye-election in Parliamentary Constituency and the schools shall be guided by the following instructions:-

- 1) The schools where the process of election up to the stage of publication of Final Voters' list have already been completed before 5/11/2011, i.e. date of enforcement of Model Code of Conduct, the remaining part shall be started after the date of declaration of Bye-election result by adopting programme afresh for the remaining part of election to be held by 31/12/2011. (X-Mas day 25/12/2011 to be avoided)
- 2) The schools where election of different categories other than Officer Bearers' election have already been completed prior to declaration of the date of enforcement of Model Code of Conduct for the ensuing Bye-election being 5/11/2011, the election of Officer Bearers shall be fixed after the date of declaration of result of the Bye-election.
- 3) The tenure of the Managing Committee / Ad-hoc-Committee / Organising Committee / Administrator of the Non-Govt. Recognised Secondary Schools of South 24 Parganas Districts of West Bengal is extended upto 31/12/2011 or till completion of the Constitution / Reconstitution of the Managing Committee (as the case may be) whichever is earlier. Schools of Kolkata District enjoying benefit extension upto 31/12/2011 in terms of the Board's Circular No. S/171 dated 29/08/2011 will be guided by the conditions of this Circular.
- 4) The Board, however, reserves the right to appoint Administrator/ Ad-hoc-Committee where the same would be necessary for administrative reasons.

- 5) The above Notification is not applicable to Schools where any order from the Hon'ble Court prevails.
