ORDER

No. 26/Pres1/10

Consequent upon the decision to start the academic session from 1st January instead of 1st May, in a phase wise manner, vide notification no 635-SE/10M-39/2009 dated 16th June,2009 issued by the Govt. of West Bengal in the School Education Department(Secondary Branch), the academic session has commenced from 1st March for the academic year 1st March,2010 to 31st January,2011 and the academic session shall commence from 1st February for the academic year 1st February,2011 to 31st December,2011 during the transitional period.


Now, in exercise of the power conferred upon me in the Note (i) of Clause 4 of the procedure, I, Dr.Mamata Ray, The President of the West Bengal Board of Secondary Education do hereby pass order to the effect that the process of election for constitution or re-constitution of managing committee viz. , preparation of provisional voters list under the category of guardian etc. , shall not commence before 16th May and 16th April for the academic year 1st March,2010 to 31st January,2011 and for the academic year 1st February,2011 to 31st December,2011 respectively.

Further, in exercise of the power conferred upon me in the Note (ii) of Clause 4 of the procedure, I do pass order to the effect that the date of election under the category of guardians for constitution or re-constitution of managing committee shall not be fixed before 16th June and 16th May for the academic year 1st March,2010 to 31st January,2011 and for the academic year 1st February,2011 to 31st December,2011 respectively.

Further, in exercise of the power conferred upon me in the Note (ii) of Clause 8 of the procedure, I do pass order to the effect that no first admission up to class- IX shall be made after the 15th May and 15th April for the academic year 1st March, 2010 to 31st January, 2011 and for the academic year 1st February, 2011 to 31st December,2011 respectively, without the prior approval of the Board in exceptional circumstances. However, admission of people on transfer from recognized institution may be made up to 31st October and 30th September for the academic year 1st March,2010 to 31st January,2011 and for the academic year 1st February,2011 to 31st December,2011 respectively, on valid ground, if not otherwise directed by the Board.

Further, in exercise of the power conferred upon me in the Sub-Clause (a) of Clause 30 of the procedure, I do pass order to the effect that (i) in case a ward is sent up for the Madhyamik Pariksha(SE) in the academic year 1st May,2009 to 28th February,2010, the eligibility of the Guardian-voter in respect of the ward have ceased from 1st March,2010 and (ii) in case a ward is sent up for the Madhyamik Pariksha(SE) in the academic year 1st March,2010 to 31st January,2011, the eligibility of the Guardian-voter in respect of the ward shall cease from 1st February,2011.

The Secretary of the Board is requested to circulate the order for strict compliance.
